## **INTRODUCTION**

### **Executive summary**

This document is a desk-top collation by the IHBC's director, Dr Seán O'Reilly, using recent research and empirical studies into standards in conservation skills and services. The table of skills and services under consultation has been developed from a body of work undertaken by professional interests across the historic environment and conservation sectors. Skills and services are classified into three parts which correspond to the main activities in historic environment conservation as defined in the IHBC's membership assessment criteria: Evaluation, Management and Intervention.

Different versions and drafts have been the subject of limited consultation inside and outside the IHBC. However the document remains a working draft at present.

Key resources for the definition of activities include work carried out by Dr Stuart Eydmann and Dr Carol Swanson for Scotland, Nicholas Johnson for Cornwall and by John Preston, the Chair of the IHBC's Education, Training and Standards Committee, much of which is carried on the IHBC's website. This work has been supplemented by wider consultation across the IHBC's committees.

The IHBC is seeking comments on all aspects of the document.

### **Application**

The document is intended to help inform the definition of standards of both an individual's skills in historic environment conservation and the services that should be expected from historic environment conservation bodies in local and, as appropriate, national government.

The classification of activities originates in both the IHBC's membership criteria, the Areas of Competence and their corresponding competences, together with the activities of historic environment services.

Continuity between the standards appropriate to both skills and services is to be expected. The IHBC's competences represent the fundamental skills set for a conservation professional. Informed by national and international standards, they have been developed out of the skills sets required by conservation professionals, and in particular by Conservation Officers working in local planning authorities. As such these standards represent a microcosm of the services that should be available through the local authority if it is to fulfil its statutory duties and civic obligations to historic environment conservation.

### **Context**

The Areas of Competence and the corresponding competences represent the standard for the assessment of skills, knowledge, experience and understanding that the IHBC requires of historic environment conservation professionals (see [www.ihbc.org.uk](http://www.ihbc.org.uk)). Demonstration of an appropriate standard within the Areas of Competence confirms an individual's capacity to operate within the holistic framework and inter-disciplinary environment demanded in historic environment management and conservation. As such, they constitute the criteria for full professional membership of the IHBC.

The Areas of Competence, and the corresponding competences, are summarised as follows:

The IHBC's Areas of Practical Competence can map to wider policy and management processes, further integrating the skills and the service. For example the three Areas of Practical Competence can be mapped to the generic skills that have been identified by Sir John Egan as underpinning the creation of sustainable communities – (see <http://www.communities.gov.uk/publications/communities/eganreview>). Similarly these can also fit with generic management outcomes for local authorities, outcomes that should be applicable across the UK, as the table indicates:

This document uses the first and last of these models as a starting point in structuring the description of standards of skills and services.

### **England and UK Context**

This document is intended to have applications across the UK. There is, however, a necessary and appropriate focus on reform of conservation operations in England and Wales, generically referred to as Heritage Protection Reform (HPR). Allied to this is the relevance of the current discussion to changes in local government proposed in England.

The wider changes shaping HPR include:

- the need for more effective integration of systems (legislative and otherwise) used in the conservation of the historic environment, in particular links to the planning system
- increased transparency in the management processes
- enhanced inclusion and the promotion of community interests, opportunities and responsibilities
- wider benefits shaping historic environment conservation, not envisaged in

- original conservation legislation, including:
  - environmental benefits, including biodiversity, carbon reduction
  - community benefits, including quality of life and social capital
  - cultural benefits, including wider appreciation of what might be valued for conservation
  - extending conservation processes to encompass a more widely defined historic environment
  - the need to be consistent with accepted conservation philosophies and principles as well as with current practice.

Though in legislative terms HPR will impact most significantly on conservation operations in England, the institute recognises that the issues that HPR looks to address reflect wider social, cultural and economic changes across the UK. As such, the issues raised here are entirely relevant to our membership in its entirety, and to conservation across the UK.

While aspects of this document respond to initiatives such as HPR, the primary intention is to create a standard that can be applied across the UK.

### **UK compliance**

There are significant differences between the conservation and planning operations across the devolved and regional administrations. As yet, these have been only provisionally addressed in the current document. A key purpose of the consultation is to develop applicability across the UK.

### **Cautionary notes**

This document is necessarily the product of a number of individual and collective interests and strengths. It does not yet provide a definitive statement of the skills or services or approaches to their development. Achieving such a definition is one of the objects of the consultation.

In addition the document does not reflect entirely the skills sets relevant to an applicant seeking full membership of the IHBC. In particular it does not encompass skills sets that can lie outside the areas of expertise or service typical of a planning authority service, such as in archaeology and architecture.
